# 1. Information and scope of inspection

This section tells you about the type, accommodation, neighbourhood, age and construction of the property. It also tells you about the extent of the inspection and highlights anything that the surveyor could not inspect.

All references to visual inspection refer to an inspection from within the property without moving any obstructions and externally from ground level within the site and adjoining public areas. Any references to left or right in a description of the exterior of the property refer to the view of someone standing facing that part of the property from the outside.

The inspection is carried out without causing damage to the building or its contents and without endangering the occupiers or the surveyor. Heavy furniture, stored items and insulation are not moved. Unless identified in the report the surveyor will assume that no harmful or hazardous materials or techniques have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

Services such as TV/cable connection, internet connection, swimming pools and other leisure facilities etc. will not be inspected or reported on.

<b>Accommodation</b>	The accommodation comprises: Entrance Vestibule, Hall, Lounge, Dining Room, Kitchen, Utility Room, Three Bedrooms (one with en-suite facilities) and Bathroom.

<b>Neighbourhood and location</b>	<p>The subjects are situated within an attractive semi-rural location, close to the hamlet of Keltneyburn, approximately 5 miles to the west of the town of Aberfeldy where there is provision for everyday amenities.</p> <p>The subjects are approached via a private road, over which it is understood a right of access is held. Situated on an attractive elevated plot, the subjects benefit from open views over the neighbouring agricultural fields.</p>

<b>Weather</b>	The weather was dry at the time of our inspection.

<b>Chimney stacks</b>	<p>Visually inspected with the aid of binoculars where appropriate.</p> <p>There is a rendered masonry chimney stack with metal flashing beneath.</p>

<b>Roofing including roof space</b>	<p>Sloping roofs were visually inspected with the aid of binoculars where appropriate.</p> <p>Flat roofs were visually inspected from vantage points within the property and where safe and reasonable to do so from a 3m ladder externally.</p> <p>Roof spaces were visually inspected and were entered where there was safe and reasonable access, normally defined as being from a 3m ladder within the property. If this is not possible, then physical access to the roof space may be taken by other means if the Surveyor deems it safe and reasonable to do so.</p> <p>The roof comprises of pitched timber construction, overlaid with concrete interlocking tiles and finished with tiled ridging, metal valley gutters and plastic dry verges.</p> <p>Access to the roof void is via a ceiling hatch and sliding metal ladder. The roof void is insulated in full, between and over the supporting joists beneath. Full and safe passage was not possible in the absence of flooring or crawl boards. A restricted "head and shoulders" inspection was carried out by torchlight from a standing ladder. Insulation present was not lifted nor disturbed.</p>

<b>Rainwater fittings</b>	<p>Visually inspected with the aid of binoculars where appropriate.</p> <p>The rainwater system comprises of plastic manufacture with half-round gutters connecting to rounded downpipes. There are metal lined valley gutters.</p>

<b>Main walls</b>	<p>Visually inspected with the aid of binoculars where appropriate. Foundations and concealed parts were not exposed or inspected.</p> <p>The walls are consistent with cavity timber frame construction, externally finished with dry dash render.</p>
<b>Windows, external doors and joinery</b>	<p>Internal and external doors were opened and closed where keys were available.</p> <p>Random windows were opened and closed where possible.</p> <p>Doors and windows were not forced open.</p> <p>There are timber and part-glazed timber external doors, with timber soffit, fascia and barge boards to the roof perimeter.</p> <p>The windows comprise of timber framed, double glazed installations.</p>
<b>External decorations</b>	<p>Visually inspected.</p>
<b>Conservatories / porches</b>	<p>None.</p>
<b>Communal areas</b>	<p>None.</p>
<b>Garages and permanent outbuildings</b>	<p>Visually inspected.</p> <p>There is an integral single garage, constructed from concrete blocks beneath a pitched, timber frame roof which is overlaid with concrete interlocking tiles. The garage is accessed via an "up and over" vehicular door, with a timber pedestrian door to the rear.</p> <p>A short distance to the rear, there is a traditional stone barn/byre, beneath a pitched timber framed roof which is overlaid with slates.</p>

<b>Outside areas and boundaries</b>	<p>Visually inspected.</p> <p>The subjects are approached via a private road, over which it is understood a right of access is held. Situated on an attractive elevated plot, the subjects benefit from open views over the neighbouring agricultural fields. There is garden to the front, sides and rear enclosed mainly within timber fences. The grounds are moderately sloping, back to front, with the rear garden being of split level design incorporating retaining walls constructed from concrete block.</p> <p>The total landholding is understood to extend to 11.57 acres, comprising the immediate formal gardens, and additional ground to the North, East and South of the house, with the land to the south extending to the banks of the River Lyon.</p>

<b>Ceilings</b>	<p>Visually inspected from floor level.</p> <p>The ceilings are consistent with plasterboard.</p>

<b>Internal walls</b>	<p>Visually inspected from floor level.</p> <p>Using a moisture meter, walls were randomly tested for dampness where considered appropriate.</p> <p>The walls are consistent with plasterboard.</p>

<b>Floors including sub floors</b>	<p>Surfaces of exposed floors were visually inspected. No carpets or floor coverings were lifted.</p> <p>Sub-floor areas were inspected only to the extent visible from a readily accessible and unfixed hatch by way of an inverted "head and shoulders" inspection at the access point.</p> <p>Physical access to the sub floor area may be taken if the Surveyor deems it is safe and reasonable to do so , and subject to a minimum clearance of 1m between the underside of floor joists and the solum as determined from the access hatch.</p> <p>The floors comprise of suspended timber construction. Fitted floor coverings restricted our inspection.</p> <p>A floor hatch was lifted within the hall cupboard, allowing for a restricted, inverted "head and shoulders" inspection of the sub-floor. The solum, where inspected, was noted to be sealed with concrete.</p>

<b>Internal joinery and kitchen fittings</b>	<p>Built-in cupboards were looked into but no stored items were moved.</p> <p>Kitchen units were visually inspected excluding appliances.</p> <p>The internal doors comprise of timber and part-glazed timber construction, with timber skirting and door surrounds.</p> <p>There is a fitted kitchen with floor and wall mounted cabinets.</p> <p>There are fitted wardrobes within the bedrooms and additional storage which is accessed from within the hall.</p>

<b>Chimney breasts and fireplaces</b>	<p>Visually inspected. No testing of the flues or fittings was carried out.</p> <p>There is a fireplace opening within the main reception room.</p>

<b>Electricity</b>	<p>Accessible parts of the wiring were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.</p> <p>Mains connection.</p>

<b>Gas</b>	<p>Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.</p> <p>There is no mains gas supplied.</p>

<b>Water, plumbing, bathroom fittings</b>	<p>Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.</p> <p>It should be appreciated that concealed areas beneath and around baths and shower trays could not be inspected. Water spillage in these areas can result in dampness/decay and no comment can be made on inaccessible areas. Waterproof seals in sanitary areas should be checked and maintained on a regular basis.</p> <p>There is a communal private water supply, gravity fed from a hillside holding tank.</p> <p>The plumbing, where seen, comprised mainly of copper and other modern materials.</p> <p>Bathroom - coloured three piece suite.</p> <p>En-suite - coloured toilet, wash basin and shower enclosure.</p>

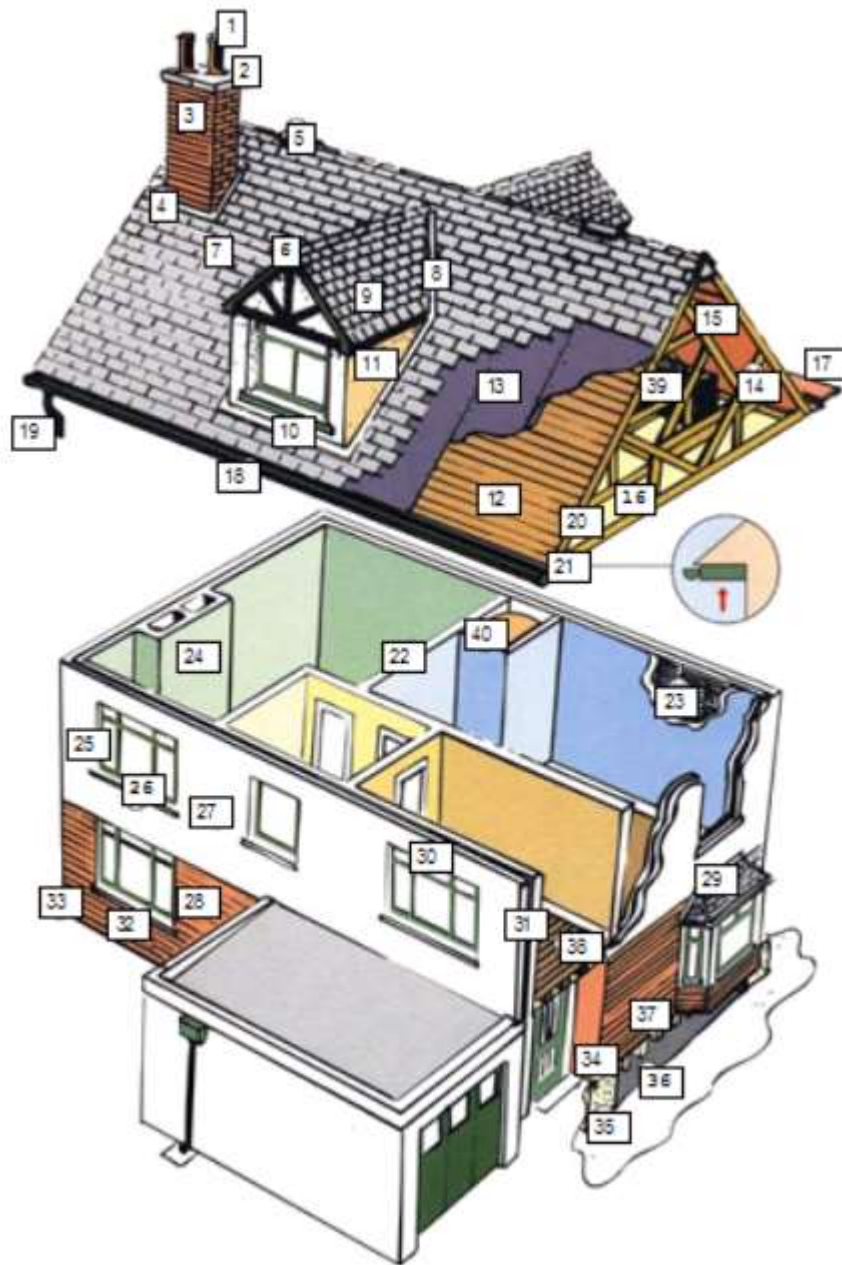
<b>Heating and hot water</b>	<p>Accessible parts of the system were visually inspected apart from communal systems, which were not inspected. No tests whatsoever were carried out to the system or appliances.</p> <p>There is an oil-fired central heating system served via a floor standing boiler, with heat provided to the main apartments via radiators.</p> <p>Hot water is provided via the heating system, in conjunction with an electric immersion heater and pre-insulated storage cylinder.</p>

<b>Drainage</b>	<p>Drainage covers etc were not lifted. Neither drains nor drainage systems were tested.</p> <p>There is a private sewage system (septic tank) which is located within the grounds. This was not inspected.</p>

<b>Fire, smoke and burglar alarms</b>	<p>Visually inspected.</p> <p>No tests whatsoever were carried out to the system or appliances.</p> <p>New smoke alarm standards were introduced in Scotland in February 2022. In instances where alarms are in place, no tests whatsoever have been carried out and we cannot confirm if the system complies with the most recent regulations. Any potential purchaser should satisfy themselves as to whether the current system meets with regulations or otherwise.</p>

<p><b>Additional limits to inspection</b></p>	<p>Fitted floor coverings restricted our inspection.</p> <p>A restricted "head and shoulders" inspection only was possible within the roof void. Insulation present was not lifted nor disturbed.</p> <p>The services were not tested, and no inspection was carried out of the septic tank.</p> <p>It is not within the scope of this inspection to determine whether or not asbestos based products are present within the property. Asbestos was widely used in the building industry until around 1999, when it became a banned substance. If you have any concerns you should engage the services of a qualified asbestos surveyor.</p> <p>No inspection for Japanese Knotweed was carried out and unless otherwise stated for the purpose of this report, it is assumed that there is no Japanese Knotweed within the boundaries of the property or neighbouring properties.</p> <p>It should be appreciated that the Home Report inspection is a non-disruptive visual inspection of the property as at the date of inspection and that we are unable to inspect parts of the property which are concealed or covered by floor coverings or contents in place at that time. Once vacant, defects may be apparent that could not be detected during our survey. Changing weather conditions can also affect aspects of the property which would not be apparent at the time of inspection.</p>

This type and age of roof will require regular careful maintenance and it is recommended that further advice is obtained from a reputable roofing contractor with comment provided as to both condition and expected lifespan.</p> <p>There is a build-up of moss, heavy in part, with vegetation noted to have gathered in the valley gutters. Careful removal is recommended.</p>

Notes	<p>There is staining beneath the gutters, and around the junctions/joints consistent with prior or intermittent spillage/leakage. Repairs should be expected as part of a normal programme of routine maintenance.</p>

Notes	<p>Barn/Byre - this is in a dilapidated state of repair, with partial collapse of the outer wall (north corner) noted. The roof requires a comprehensive programme of repair, there is wood rot and wood borer beetle to timbers, failure of the timber safe lintel and defective rainwater goods.</p> <p>The summerhouse appeared in a condition commensurate with age and type, and attention is required to the timber and felt tiled roof over.</p> <p>Garage - there are displaced and broken boards to the underside of the roof, and damage was noted to the concrete threshold to the base of the rear door.</p>

Notes	<p>There is cracking and indication of movement to the retaining walls (rear), and widespread decay to the timber guardrails. Substantial repairs are required.</p> <p>There is spalling brick to the rear entrance stairs, with damage noted to the concrete slab and rot was noted to the timber fences. Repairs will be required as part of a normal programme of routine maintenance.</p>

Notes	Cracking and blemishes have occurred and some plaster repairs may be required (during redecoration).

As such there is an increased risk of water spillage to concealed areas and it would be prudent to ensure these are maintained in a watertight condition.</p> <p>There is stained render to the rear which appears to be the result of a leak from the overflow pipe above. Early repair is advised.</p>

Restricted parking includes parking that is subject to parking restrictions, as indicated by the presence of solid yellow, red or white lines at the edge of the road or by a parking control sign, parking meters or other coin-operated machines.

#### 4. Valuation and conveyance issues

We are unaware of any adverse planning proposals affecting the subjects although this should be confirmed by obtaining a Property Enquiry Certificate.

Absolute Ownership assumed. We are unaware of any easements, servitudes or rights of way which may adversely affect the property. This point should be confirmed by reference to the Title Deeds.

There is a communal private water supply, gravity fed from a hillside holding tank. This source is assumed to be reliable. Neither the reliability nor purity of the supply have been tested and purchasers should satisfy themselves in these respects. It is our understanding that the supply has passed a recent water test, and that UV sterilisation and a new water filter are to be fitted prior to sale.

There is a private sewage system (septic tank) which is located within the grounds. This was not inspected, and it should be ensured that the appropriate registration documents are held.

The subjects are approached via a private road, over which it is understood a right of access is held and that burden for upkeep and repair will be apportioned on a fair and equitable basis. The purchasing solicitor will require to confirm that the legal arrangements are adequate.

The total landholding is understood to extend to 11.57 acres, comprising the immediate formal gardens, and additional ground to the North, East and South of the house, with the land to the south extending to the banks of the River Lyon.

##### **Estimated reinstatement cost for insurance purposes**

£500,000

The guidance figure is the estimate of costs for reinstating the subjects as at the date of inspection based on information provided by the Building Cost Information Service (BCIS). Building costs are currently increasing significantly above inflation due to increased demand and supply issues as a result of Brexit and the pandemic. It is recommended that this figure is kept under regular review to ensure that you have adequate insurance cover.

We are of the opinion that the subjects should be insured for buildings reinstatement purposes for a sum of not less than £500,000 (FIVE HUNDRED THOUSAND POUNDS STERLING).

## TERMS AND CONDITIONS OF SINGLE SURVEY

### GENERAL

#### 1.1 The Surveyors

The Seller has engaged the Surveyors to provide the Report and a Generic Mortgage Valuation Report for Lending Purposes. The Seller has also engaged the Surveyors to provide an Energy Report in the format prescribed by the accredited energy company.

The Surveyors are authorised to provide a transcript or retype of the Generic Mortgage Valuation Report on to Lender specific pro-forma. Transcript reports are commonly requested by brokers and lenders. The transcript report will be in the format required by the Lender but will contain the same information, inspection date and valuation figure as the Generic Mortgage Valuation Report and the Report. The Surveyors will decline any transcript request which requires the provision of information additional to the information in the Report and the Generic Mortgage Valuation Report until the Seller has conditionally accepted an offer to purchase made in writing.

Once the Seller has conditionally accepted an offer to purchase made in writing, the Lender or conveyancer may request that the Surveyors provide general comment on standard appropriate supplementary documentation. In the event of a significant amount of documentation being provided to the Surveyors, an additional fee may be incurred by the Purchaser. Any additional fee will be agreed in writing.

If information is provided to the Surveyors during the conveyancing process which materially affects the valuation stated in the Report and Generic Mortgage Valuation Report, the Surveyors reserve the right to reconsider the valuation. Where the Surveyors are required to amend the valuation in consequence of such information, they will issue an amended Report and Generic Mortgage Valuation Report to the Seller. It is the responsibility of the Seller to ensure that the amended Report and Generic Mortgage Valuation Report are transmitted to every prospective Purchaser.

The individual Surveyor will be a member of the Royal Institution of Chartered Surveyors who is competent to survey, value and report upon residential property. \*

If the Surveyors have had a previous business relationship within the past two years with the Seller or Seller's agent or relative to the Property, they will be obliged to indicate this in the adjacent box.  Yes

The Surveyors have a written complaints handling procedure. This is available from the offices of the Surveyors at the address stated.

#### 1.2 The Report

The Surveyors will not provide an amended Report on the Property, except to correct factual inaccuracies.

The Report will identify the nature and source of information relied upon in its preparation.

The Surveyor shall provide a Market Value of the Property, unless the condition of the Property is such that it would be inappropriate to do so. A final decision on whether a loan will be granted rests with the Lender who may impose retentions in line with their lending criteria. The date of condition and value of the property will be the date of inspection.

The Surveyors acknowledge that their duty of skill and care in relation to the Report is owed to the Seller and to the Purchaser. The Surveyors accept no responsibility or liability whatsoever in relation to the Report to persons other than the Seller and the Purchaser. The Seller and Purchaser should be aware that if a Lender seeks to rely on this Report they do so at their own risk. In particular, the Surveyors accept no responsibility or liability whatsoever to any Lender in relation to the Report. Any such Lender relies upon the Report entirely at their own risk.

## DESCRIPTION OF THE REPORT

### 2.1 The Service

The Single Survey is a Report by an independent Surveyor, prepared in an objective way regarding the condition and value of the Property on the day of the inspection, and who is a member of the Royal Institution of Chartered Surveyors. It includes an Energy Report as required by statute and this is in the format of the accredited energy company. In addition, the Surveyor has agreed to supply a generic Mortgage Valuation Report.

### 2.2 The Inspection

The inspection is a general surface examination of those parts of the Property which are accessible: in other words, **visible and readily available for examination from ground and floor levels without risk of causing damage to the Property or injury to the Surveyor.**

All references to visual inspection refer to an inspection from within the Property at floor level and from ground level within the site and adjoining public areas, without the need to move any obstructions. Any references to left or right are taken facing the front of the Property.

The inspection is carried out with the Seller's permission, without causing damage to the building or contents. Furniture, stored items and insulation are not moved.

Unless identified in the Report the Surveyor will assume that no harmful or hazardous materials have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

The Surveyor will not carry out an asbestos inspection, and will not be acting as an asbestos inspector in completing a Report of Property that may fall within the Control of Asbestos in the Workplace Regulations. In the case of flats it will be assumed that there is a duty holder, as defined in the Regulations and that a register of asbestos and effective management plan is in place, which does not require any expenditure, or pose a significant risk to health. No enquiry of the duty holder will be made.

### 2.3 The Report

The Report will be prepared by the Surveyor who carried out the Property inspection and will describe various aspects of the Property as defined by the headings of the Single Survey report with the comments being general and unbiased. The report on the location, style and condition of the Property will be concise and will be restricted to matters that could have a material affect upon value and will omit items that, in the Surveyor's opinion, are not significant. If certain minor matters are mentioned, it should not be interpreted that the Property is free of any other minor defects.

Throughout the Report the following repair categories will be used to give an overall opinion of the state of repair and condition of the Property:

#### 2.3.1 Category 3:

Urgent repairs or replacement are needed now. Failure to deal with them may cause problems to other parts of the Property or cause a safety hazard. Estimates for repairs or replacement are needed now.

The subjects are situated within an attractive semi-rural location, close to the hamlet of Keltneyburn, approximately 5 miles to the west of the town of Aberfeldy where there is provision for everyday amenities.

The walls are consistent with cavity timber frame construction, externally rendered with the roof over being pitched and overlaid with concrete interlocking tiles.

At the time of our inspection the subjects were found to be in a condition commensurate with age and type, with no significant items of repair outstanding which would have a material affect on the valuation reported. There are a number of items of wear and tear, and repairs will be required during a normal programme of routine maintenance. The works required include upgrading of the fabric, fittings and services.

There is a communal private water supply, gravity fed from a hillside holding tank. This source is assumed to be reliable. Neither the reliability nor purity of the supply have been tested and purchasers should satisfy themselves in these respects. It is our understanding that the supply has passed a recent water test, and that UV sterilisation and a new water filter are to be fitted prior to sale.

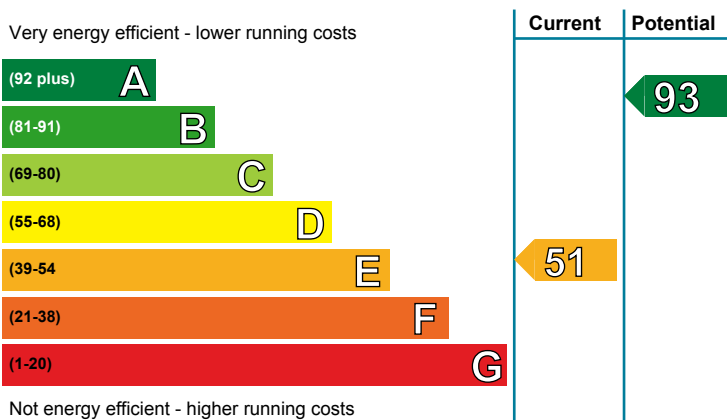

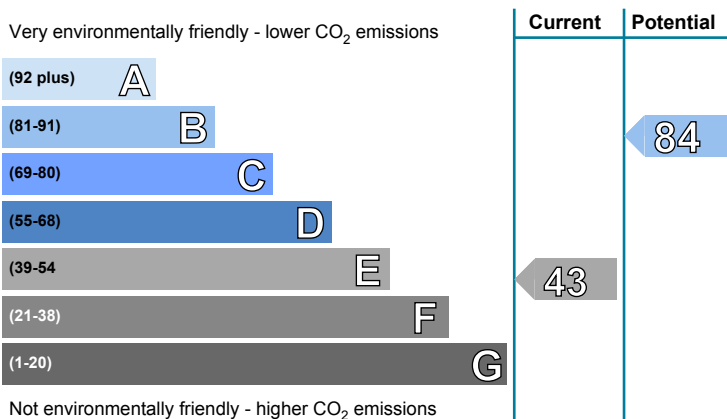

## The energy efficiency rating of your home

Your Energy Efficiency Rating is calculated using the standard UK methodology, RdSAP. This calculates energy used for heating, hot water, lighting and ventilation and then applies fuel costs to that energy use to give an overall rating for your home. ## The impact of your home on the environment











### 1 Floor insulation (suspended floor)

Insulation of a floor will significantly reduce heat loss; this will improve levels of comfort, reduce energy use and lower fuel bills. Suspended floors can often be insulated from below but must have adequate ventilation to prevent dampness; seek advice about this if unsure. Building regulations generally apply to this work so it is best to check with your local authority building standards department.

### 2 Condensing boiler

A condensing boiler is capable of much higher efficiencies than other types of boiler, meaning it will burn less fuel to heat this property. This improvement is most appropriate when the existing central heating boiler needs repair or replacement, however there may be exceptional circumstances making this impractical. Condensing boilers need a drain for the condensate which limits their location; remember this when considering remodelling the room containing the existing boiler even if the latter is to be retained for the time being (for example a kitchen makeover). Building regulations generally apply to this work and a building warrant may be required, so it is best to check with your local authority building standards department and seek advice from a qualified heating engineer.

### 3 Solar water heating

A solar water heating panel, usually fixed to the roof, uses the sun to pre-heat the hot water supply. This can significantly reduce the demand on the heating system to provide hot water and hence save fuel and money. Planning permission might be required, building regulations generally apply to this work and a building warrant may be required, so it is best to check these with your local authority. You could be eligible for Renewable Heat Incentive payments which could appreciably increase the savings beyond those shown on your EPC, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent). ### 4 Solar photovoltaic (PV) panels

A solar PV system is one which converts light directly into electricity via panels placed on the roof with no waste and no emissions. This electricity is used throughout the home in the same way as the electricity purchased from an energy supplier. Planning permission might be required, building regulations generally apply to this work and a building warrant may be required, so it is best to check with your local authority. The assessment does not include the effect of any Feed-in Tariff which could appreciably increase the savings that are shown on this EPC for solar photovoltaic panels, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent). ### 5 Wind turbine
