# 1. Information and scope of inspection

This section tells you about the type, accommodation, neighbourhood, age and construction of the property. It also tells you about the extent of the inspection and highlights anything that the surveyor could not inspect.

All references to visual inspection refer to an inspection from within the property without moving any obstructions and externally from ground level within the site and adjoining public areas. Any references to left or right in a description of the exterior of the property refer to the view of someone standing facing that part of the property from the outside.

The inspection is carried out without causing damage to the building or its contents and without endangering the occupiers or the surveyor. Heavy furniture, stored items and insulation are not moved. Unless identified in the report the surveyor will assume that no harmful or hazardous materials or techniques have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

Services such as TV/cable connection, internet connection, swimming pools and other leisure facilities etc. will not be inspected or reported on.

<b>Description</b>	The subjects comprise a detached predominantly two storey dwelling house with part two storey and part single storey rear extension.
<b>Accommodation</b>	Entrance Porch, Living Room with adjoining Study, Kitchen, Utility Area with WC and Sun Lounge.  First Floor: Three Bedrooms and Shower Room.
<b>Gross internal floor area (m<sup>2</sup>)</b>	146
<b>Neighbourhood and location</b>	The subjects are located a short distance to the east of Methven within the original grounds of Methven Castle. There are a number of properties in the immediate vicinity, although the surrounding area is agricultural in character. There are day-to-day amenities available in Methven and Perth (circa 5 miles).
<b>Age (year built)</b>	Built circa 1860.

<b>Weather</b>	It was dry at the time of inspection.

<b>Chimney stacks</b>	<p>Chimneys are of stone construction finished with metal flashings.</p> <p>Visually inspected with the aid of binoculars where appropriate.</p>

<b>Roofing including roof space</b>	<p>The roof is predominantly timber pitched and overlaid in slates, although incorporates a flat mid section which would appear overlaid with a PVC membrane. The roof incorporates a timber and slated rear dormer. There is an access hatch to the roof void on the upper landing, although contents heavily restricted the inspection and no access was obtained beyond the hatch. Insulation present also heavily restricted the inspection.</p> <p>Sloping roofs were visually inspected with the aid of binoculars where appropriate.</p> <p>Flat roofs were visually inspected from vantage points within the property and where safe and reasonable to do so from a 3m ladder externally.</p> <p>Roof spaces were visually inspected and were entered where there was safe and reasonable access, normally defined as being from a 3m ladder within the property. If this is not possible, then physical access to the roof space may be taken by other means if the Surveyor deems it safe and reasonable to do so.</p>

<b>Rainwater fittings</b>	<p>Gutters and downpipes are a mixture of cast iron and PVC installations. There are no rainwater goods at the dormer.</p> <p>Visually inspected with the aid of binoculars where appropriate.</p>

<b>Main walls</b>	<p>The original walls are of traditional stone construction (partially rendered). The extension is more consistent with a load bearing inner timber frame with block outer leaf rendered externally. The sun lounge is of a more lightweight construction, possibly timber and clad externally.</p> <p>Visually inspected with the aid of binoculars where appropriate. Foundations and concealed parts were not exposed or inspected.</p>

<b>Windows, external doors and joinery</b>	<p>Windows mainly comprise a mixture of uPVC sealed unit double glazing and timber casement double glazing. Some timber single glazed windows also remain. External doors comprise uPVC sealed unit double glazed installations to the front and rear.</p> <p>Internal and external doors were opened and closed where keys were available.</p> <p>Random windows were opened and closed where possible.</p> <p>Doors and windows were not forced open.</p>
<b>External decorations</b>	Visually inspected.
<b>Conservatories / porches</b>	There is no conservatory/porch.
<b>Communal areas</b>	There are no communal areas within the fabric of the property.
<b>Garages and permanent outbuildings</b>	<p>There is a stone and slate garden store to the north side of the property. No internal access was obtained at the time of inspection.</p> <p>Visually inspected.</p>
<b>Outside areas and boundaries</b>	<p>Areas of garden ground are provided around the property and these include an area for off street parking. Gardens include an area of walled garden with high level stone and brick walls. There are also areas of timber fencing.</p> <p>There is no defined boundary to the west most portion of the garden, and the full extent of the grounds will require to be confirmed through reference to the deeds and associated title plans.</p> <p>Visually inspected.</p>
<b>Ceilings</b>	<p>A mixture of lath and plaster and plasterboard.</p> <p>Visually inspected from floor level.</p>

<b>Internal walls</b>	<p>A mixture of lath and plaster and plasterboard.</p> <p>Visually inspected from floor level.</p> <p>Using a moisture meter, walls were randomly tested for dampness where considered appropriate.</p>

<b>Floors including sub floors</b>	<p>Flooring is partly solid/concrete at ground floor level and suspended timber in the rear extension. The upper floor is also of suspended timber. There were fitted floor coverings present throughout restricting the inspection and no access was obtained to inspect any sub-floor area.</p> <p>Surfaces of exposed floors were visually inspected. No carpets or floor coverings were lifted.</p> <p>Sub-floor areas were inspected only to the extent visible from a readily accessible and unfixed hatch by way of an inverted "head and shoulders" inspection at the access point.</p> <p>Physical access to the sub floor area may be taken if the Surveyor deems it is safe and reasonable to do so , and subject to a minimum clearance of 1m between the underside of floor joists and the solum as determined from the access hatch.</p>

<b>Internal joinery and kitchen fittings</b>	<p>There is a fitted kitchen comprising floor and wall mounted units which are painted. Internal doors are timber and there is a timber and carpeted internal stair.</p> <p>Built-in cupboards were looked into but no stored items were moved.</p> <p>Kitchen units were visually inspected excluding appliances.</p>

<b>Chimney breasts and fireplaces</b>	<p>There is a wood burning stove in the living room flued through the adjoining chimney. A fireplace also remains in the upper floor bedroom. This does not appear to be currently used.</p> <p>Visually inspected. No testing of the flues or fittings was carried out.</p>

<b>Internal decorations</b>	<p>Visually inspected.</p>

<b>Cellars</b>	There is no cellar pertaining to the property.
<b>Electricity</b>	<p>Mains electricity. The main consumer unit houses circuit breakers.</p> <p>Accessible parts of the wiring were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.</p>
<b>Gas</b>	<p>Understood to be mains gas. There is a gas fired central heating system.</p> <p>Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.</p>
<b>Water, plumbing, bathroom fittings</b>	<p>Assumed to be mains water. Visible plumbing is mainly copper and PVC. There is a three piece white suite in the shower room. There is also a WC in the utility area.</p> <p>Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.</p> <p>It should be appreciated that concealed areas beneath and around baths and shower trays could not be inspected. Water spillage in these areas can result in dampness/decay and no comment can be made on inaccessible areas. Waterproof seals in sanitary areas should be checked and maintained on a regular basis.</p>

<b>Heating and hot water</b>	<p>There is a gas fired central heating system served by a Worcester condensing combination boiler which is wall mounted in the utility area. Heat is distributed internally via radiators. The central heating also provides the hot water supply.</p> <p>Accessible parts of the system were visually inspected apart from communal systems, which were not inspected. No tests whatsoever were carried out to the system or appliances.</p>

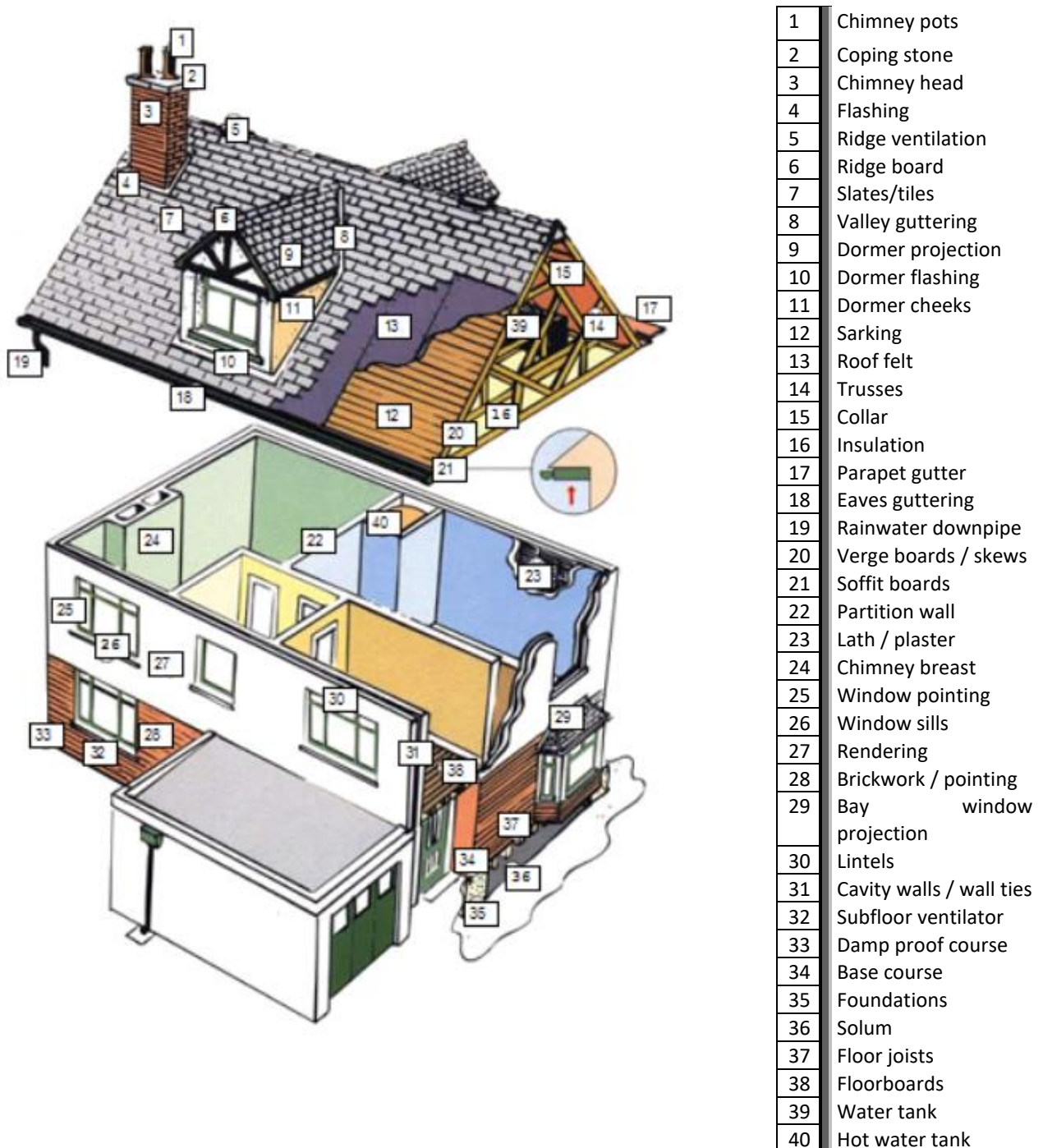
<b>Drainage</b>	<p>Assumed to be to a septic tank. This was not checked tested.</p> <p>Drainage covers etc were not lifted.</p> <p>Neither drains nor drainage systems were tested.</p>

<b>Fire, smoke and burglar alarms</b>	<p>Visually inspected. No tests whatsoever were carried out to the system or appliances. New smoke alarm standards were introduced in Scotland in February 2022 and it is likely that some properties may require additional works to meet these standards. In instances where alarms are in place, no tests whatsoever have been carried out and we cannot confirm if the system complies with the most recent regulations. Any potential purchaser should satisfy themselves as to whether the current system meets with regulations or otherwise.</p>

<b>Additional limits to inspection</b>	<p>The property was unoccupied at the time of inspection, although there were contents, furniture and fitted floor coverings present throughout. No access was obtained to inspect any sub-floor area and the inspection of the roof void was heavily restricted due to contents and insulation present. No meaningful access was obtained beyond the hatch. Further aspects of the external fabric including a number of areas of the roof/flat roof could not be inspected.</p> <p>It is outwith the scope of this inspection to determine whether or not asbestos based products are present within the property. Asbestos was widely used in the building industry until around 1999, when it became a banned substance. If you have any concerns you should engage the services of a qualified asbestos surveyor.</p> <p>No inspection for Japanese Knotweed was carried out and unless otherwise stated for the purpose of this report, it is assumed that there is no Japanese Knotweed within the boundaries of the property or neighbouring properties.</p> <p>It should be appreciated that the Home Report inspection is a non-disruptive visual inspection of the property as at the date of inspection and that we are unable to inspect parts of the property which are concealed or covered by floor coverings or contents in place at that time. Once vacant, defects may be apparent that could not be detected during our survey. Changing weather conditions can also affect aspects of the property which would not be apparent at the time of inspection.</p>

Notes	There is evidence of settlement in the building noted both internally and externally but this is not inconsistent with a property of this age and type and on the basis of a single inspection appears to be longstanding.	
	<b>Dampness, rot and infestation</b>

Notes	<p>Previous timber and damp specialist works have been carried out including a damp proof course and possibly woodworm treatments. The extent of documentation/guarantees should be verified.</p> <p>There are high ground levels and restricted ventilation which can cause a build up of moisture in the sub-floor area. There is also typical salting and staining of timbers within the roof void. Given the age and nature of the property in conjunction with the findings, it would be advisable to have the property fully inspected by a reputable firm specialising in the treatment of dampness and timber defects to ascertain the full extent of repairs require and likely costs in this regard.</p>

Notes	There are areas of spalling/weathered stonework, particularly at the front chimney. The rear chimney has previously been overhauled.	
	<h2 style="margin: 0;">Roofing including roof space</h2>	
Repair category	2	
Notes	<p>General maintenance, overhaul and repair of the roof coverings is now necessary and it should be appreciated that this type of roof covering, due to its age, will require constant maintenance in the future. The roof is of a complex design with a number of junctions/valleys which are all potential weak points and metalwork is of mixed age. Flat roof areas also require careful/ongoing maintenance.</p> <p>Further advice can be obtained from a roofing contractor.</p>	
	<h2 style="margin: 0;">Rainwater fittings</h2>	
Repair category	2	
Notes	Staining around gutters/downpipes could relate to water spillage and installations will require regularly cleared from leaves/debris and sealed. It was dry at the time of inspection and as such we were unable to establish the extent of any leakage. There are no rainwater goods around the dormer.	



	<h2>Main walls</h2>	
Repair category	2	
Notes	Stonework is stained/weathered and there is moss/vegetation particularly at low level which partially restricts sub-floor ventilation. Drill holes associated with the DPC have not been pointed. There is also staining/discolouration to rendered areas.	
	<h2>Windows, external doors and joinery</h2>	
Repair category	2	
Notes	The windows are of mixed age and type, with some deterioration/rot noted to the external timbers. Windows can be problematic and over time the operation of the windows can be affected and opening mechanisms damaged. Attention and repairs will be required as part of an ongoing maintenance programme.	
	<h2>External decorations</h2>	
Repair category	2	
Notes	There are areas of flaking/weathered paint and areas will require a programme of repair and decoration. This may include cutting out some timber sections and replacing as part of a routine maintenance programme.	
	<h2>Conservatories / porches</h2>

Notes	Not applicable.	

	<b>Communal areas</b>

	<b>Garages and permanent outbuildings</b>

Notes	Outbuildings are plainly presented and dependent upon proposals, some upgrading may be preferable.	
	<b>Outside areas and boundaries</b>

Notes	The property includes high level stone/brick walls relating to the original walled garden. It should be appreciated that these can be costly to maintain. Weathered/spalling sections and moss/vegetation was evident. Precise boundaries should be verified from title deeds.

Notes	Normal decorative repairs.

Notes	No significant defects apparent to accessible areas of flooring. Some loose/uneven sections were noted.

Notes	Kitchen fittings/internal joinery will require a normal programme of age related maintenance and regular decoration.

Notes	No checks were carried out to establish if the stove has been installed in compliance with appropriate regulations. This should be checked and serviced. The open fire should also be checked and swept prior to use.

Notes	Normal decorative works.

Notes	<p>The electrical system is on semi modern/mixed lines and as such we recommend that it be checked and upgraded as necessary by an NICEIC/SELECT registered Electrical Contractor.</p> <p>The Institution of Engineering and Technology recommends that inspections and testing are undertaken at least every ten years and on a change of occupancy. It should be appreciated that only the most recently constructed or re-wired properties will have installations which fully comply with IET regulations.</p>	
	<h2 style="margin: 0;">Gas</h2>	
Repair category	1	
Notes	<p>In the interest of safety all gas appliances should be checked by a Gas Safe Registered Engineer.</p>	
	<h2 style="margin: 0;">Water, plumbing and bathroom fittings</h2>	
Repair category	1	
Notes	<p>Sanitary goods and visible plumbing installations are in a condition consistent with age and usage. It would be prudent to ensure all seals are maintained in watertight condition as any spillage can lead to associated problems.</p> <p>There are damp stained timbers to the base of the shower consistent with prior or intermittent spillage/leakage. Our inspection was restricted in the presence of a fitted floor covering, and further investigation of the concealed areas would be prudent.</p>

<b>Notes</b>	There is a gas fired central heating system and gas fittings and these should all be checked and serviced in the normal manner. In the interests of safety it would be prudent to have all gas appliances checked by a Gas Safe registered tradesman.

<b>Repair category</b>	1	
<b>Notes</b>	There was no surface water evidence within the grounds of the subjects to suggest that the system is choked or leaking. It should be verified that appropriate registration documentation is available in connection with the septic tank.

### 3. Accessibility information

#### Guidance notes on accessibility information

Three steps or fewer to a main entrance door of the property: In flatted developments the ‘main entrance’ would be the flat’s own entrance door, not the external door to the communal stair. The ‘three steps or fewer’ are counted from external ground level to the flat’s entrance door. Where a lift is present, the count is based on the number of steps climbed when using the lift.

Unrestricted parking within 25 metres: For this purpose, ‘Unrestricted parking’ includes parking available by means of a parking permit. Restricted parking includes parking that is subject to parking restrictions, as indicated by the presence of solid yellow, red or white lines at the edge of the road or by a parking control sign, parking meters or other coin-operated machines.

#### 4. Valuation and conveyance issues

This section highlights information that should be checked with a solicitor or licensed conveyancer. It also gives an opinion of market value and an estimated cost for insurance purposes.

##### **Matters for a solicitor or licensed conveyancer**

Absolute Ownership assumed. We are unaware of any easements, servitudes or rights of way which may adversely affect the property. This point should be confirmed by reference to the Title Deeds.

The valuation is made on the assumption that any alterations that may have been carried out to the property satisfy all relevant legislation and have full certification where appropriate. While not necessarily an exhaustive list, alterations noted at the time of our inspection include the rear extension estimated to be some 20-30 years old.

It is recommended that where repairs, defects or maintenance items have been identified, particularly categorised as a 2 or 3, interested parties make appropriate enquiries in order to satisfy themselves of potential costs and the extent of the works required prior to submitting a legal offer to purchase.

We are unaware of any adverse planning proposals affecting the subjects although this should be confirmed by obtaining a Property Enquiry Certificate.

Access to the property is taken over a shared private unsurfaced road. It will be necessary to ensure that there are no restrictions on access and that any maintenance is on a fair and equitable basis.

There is no defined boundary to the western most portion of the garden, and the full extent of the grounds will require to be confirmed through reference to the deeds and associated title plans.

##### **Estimated reinstatement cost for insurance purposes**

£700,000

It is assumed that insurance cover is obtainable on normal terms. The guidance figure is the estimate of costs for reinstating the subjects as at the date of inspection based on information provided by the Building Cost Information Service (BCIS). It is recommended that this figure is kept under regular review to ensure that you have adequate insurance cover. We are of the opinion that the subjects should be insured for buildings reinstatement purposes for a sum of not less than £700,000 (SEVEN HUNDRED THOUSAND POUNDS STERLING).

**Valuation and market comments****£370,000**

We are of the opinion that the market value of the subjects all as previously described and on a vacant possession basis would be fairly stated in the region of £370,000 (THREE HUNDRED AND SEVENTY THOUSAND POUNDS STERLING).

## TERMS AND CONDITIONS OF SINGLE SURVEY

### GENERAL

#### 1.1 The Surveyors

The Seller has engaged the Surveyors to provide the Report and a Generic Mortgage Valuation Report for Lending Purposes. The Seller has also engaged the Surveyors to provide an Energy Report in the format prescribed by the accredited energy company.

The Surveyors are authorised to provide a transcript or retype of the Generic Mortgage Valuation Report on to Lender specific pro-forma. Transcript reports are commonly requested by brokers and lenders. The transcript report will be in the format required by the Lender but will contain the same information, inspection date and valuation figure as the Generic Mortgage Valuation Report and the Report. The Surveyors will decline any transcript request which requires the provision of information additional to the information in the Report and the Generic Mortgage Valuation Report until the Seller has conditionally accepted an offer to purchase made in writing.

Once the Seller has conditionally accepted an offer to purchase made in writing, the Lender or conveyancer may request that the Surveyors provide general comment on standard appropriate supplementary documentation. In the event of a significant amount of documentation being provided to the Surveyors, an additional fee may be incurred by the Purchaser. Any additional fee will be agreed in writing.

If information is provided to the Surveyors during the conveyancing process which materially affects the valuation stated in the Report and Generic Mortgage Valuation Report, the Surveyors reserve the right to reconsider the valuation. Where the Surveyors are required to amend the valuation in consequence of such information, they will issue an amended Report and Generic Mortgage Valuation Report to the Seller. It is the responsibility of the Seller to ensure that the amended Report and Generic Mortgage Valuation Report are transmitted to every prospective Purchaser.

The individual Surveyor will be a member of the Royal Institution of Chartered Surveyors who is competent to survey, value and report upon residential property. \*

If the Surveyors have had a previous business relationship within the past two years with the Seller or Seller's agent or relative to the Property, they will be obliged to indicate this in the adjacent box.  Yes

The Surveyors have a written complaints handling procedure. This is available from the offices of the Surveyors at the address stated.

\* Which shall be in accordance with the current RICS Appraisal and Valuation Standards (The Red Book) and RICS Rules of Conduct.

#### 1.2 The Report

The Surveyors will not provide an amended Report on the Property, except to correct factual inaccuracies.

The Report will identify the nature and source of information relied upon in its preparation.

The Surveyor shall provide a Market Value of the Property, unless the condition of the Property is such that it would be inappropriate to do so. A final decision on whether a loan will be granted rests with the Lender who may impose retentions in line with their lending criteria. The date of condition and value of the property will be the date of inspection.

Prior to the 1st of December 2008, Purchasers have normally obtained their own report from their chosen Surveyor. By contrast, a Report is instructed by the Seller and made available to all potential Purchasers in expectation that the successful Purchaser will have relied upon it. The Royal Institution of Chartered Surveyors rules require disclosure of any potential conflict of interest when acting for the Seller and the Purchaser in the same transaction. The Report may give rise to a conflict of interest and if this is of concern to any party they are advised to seek their own independent advice.

The Report and any expressions or assessments in it are not intended as advice to the Seller or Purchaser or any other person in relation to an asking price or any other sales or marketing decisions.

The Report is based solely on the Property and is not to be relied upon in any manner whatsoever when considering the valuation or condition of any other property.

If certain minor matters are mentioned in the Report it should not be assumed that the Property is free of other minor defects.

Neither the whole nor any part of the Report may be published in any way, reproduced or distributed by any party other than the Seller, prospective Purchasers and the Purchaser and their respective professional advisors without the prior written consent of the Surveyors.

### 1.3 Liability

The Report is prepared with the skill and care reasonably to be expected of a competent residential surveyor who is a member of the Royal Institution of Chartered Surveyors.

### 2.1 The Service

The Single Survey is a Report by an independent Surveyor, prepared in an objective way regarding the condition and value of the Property on the day of the inspection, and who is a member of the Royal Institution of Chartered Surveyors. It includes an Energy Report as required by statute and this is in the format of the accredited energy company. In addition, the Surveyor has agreed to supply a generic Mortgage Valuation Report.

### 2.2 The Inspection

The inspection is a general surface examination of those parts of the Property which are accessible: in other words, **visible and readily available for examination from ground and floor levels without risk of causing damage to the Property or injury to the Surveyor.**

All references to visual inspection refer to an inspection from within the Property at floor level and from ground level within the site and adjoining public areas, without the need to move any obstructions. Any references to left or right are taken facing the front of the Property.

The inspection is carried out with the Seller's permission, without causing damage to the building or contents. Furniture, stored items and insulation are not moved.

### 2.3 The Report

The Report will be prepared by the Surveyor who carried out the Property inspection and will describe various aspects of the Property as defined by the headings of the Single Survey report with the comments being general and unbiased. The report on the location, style and condition of the Property will be concise and will be restricted to matters that could have a material affect upon value and will omit items that, in the Surveyor's opinion, are not significant. 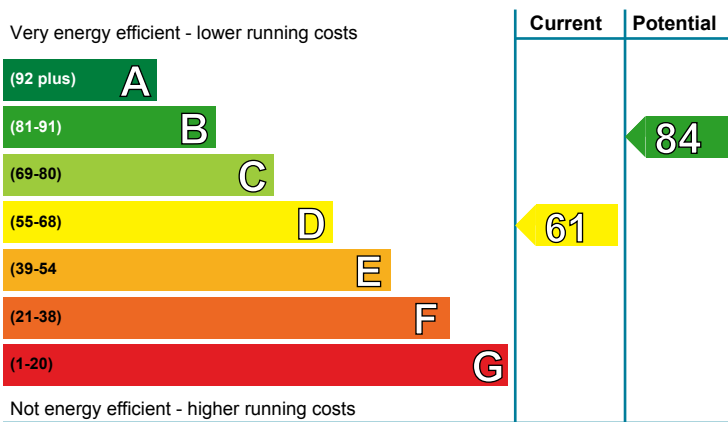

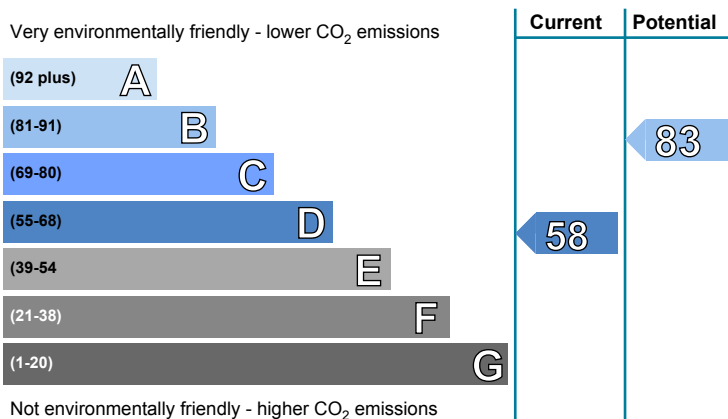

## The energy efficiency rating of your home

Your Energy Efficiency Rating is calculated using the standard UK methodology, RdSAP. This calculates energy used for heating, hot water, lighting and ventilation and then applies fuel costs to that energy use to give an overall rating for your home. The rating is given on a scale of 1 to 100. Other than the cost of fuel for electrical appliances and for cooking, a building with a rating of 100 would cost almost nothing to run.

As we all use our homes in different ways, the energy rating is calculated using standard occupancy assumptions which may be different from the way you use it. The rating also uses national weather information to allow comparison between buildings in different parts of Scotland. However, to make information more relevant to your home, local weather data is used to calculate your energy use, CO<sub>2</sub> emissions, running costs and the savings possible from making improvements.

## The impact of your home on the environment


One of the biggest contributors to global warming is carbon dioxide. The energy we use for heating, lighting and power in our homes produces over a quarter of the UK's carbon dioxide emissions. Different fuels produce different amounts of carbon dioxide for every kilowatt hour (kWh) of energy used. The Environmental Impact Rating of your home is calculated by applying these 'carbon factors' for the fuels you use to your overall energy use.

The calculated emissions for your home are 46 kg CO<sub>2</sub>/m<sup>2</sup>/yr.

The average Scottish household produces about 6 tonnes of carbon dioxide every year. Based on this assessment, heating and lighting this home currently produces approximately 6.7 tonnes of carbon dioxide every year. Adopting recommendations in this report can reduce emissions and protect the environment. If you were to install all of these recommendations this could reduce emissions by 3.8 tonnes per year. ## About the recommended measures to improve your home's performance rating

This section offers additional information and advice on the recommended improvement measures for your home

### 1 Room-in-roof insulation

Insulating roof rooms will significantly reduce heat loss; this will improve levels of comfort, reduce energy use and lower fuel bills. If it has a flat ceiling insulation can usually be added above the ceiling, and sloping ceilings and walls of roof rooms can be insulated using an internal lining board. Roof voids must have adequate ventilation to prevent dampness; seek advice about this if unsure. Further information about roof room insulation and details of local contractors can be obtained from the National Insulation Association ([www.nationalinsulationassociation.org.uk](http://www.nationalinsulationassociation.org.uk)). Building regulations generally apply to this work so it is best to check this with your local authority building standards department.

### 2 Internal or external wall insulation

Internal or external wall insulation involves adding a layer of insulation to either the inside or the outside surface of the external walls, which reduces heat loss and lowers fuel bills. As it is more expensive than cavity wall insulation it is only recommended for walls without a cavity, or where for technical reasons a cavity cannot be filled. Internal insulation, known as dry-lining, is where a layer of insulation is fixed to the inside surface of external walls; this type of insulation is best applied when rooms require redecorating. External solid wall insulation is the application of an insulant and a weather-protective finish to the outside of the wall. This may improve the look of the home, particularly where existing brickwork or rendering is poor, and will provide long-lasting weather protection. Further information can be obtained from the National Insulation Association ([www.nationalinsulationassociation.org.uk](http://www.nationalinsulationassociation.org.uk)). It should be noted that a building warrant is required for the installation of external wall insulation. Planning permission may also be required and that building regulations apply to external insulation so it is best to check with your local authority on both issues.

### 3 Floor insulation (solid floor)

Insulation of a floor will significantly reduce heat loss; this will improve levels of comfort, reduce energy use and lower fuel bills. Insulating solid floors can present challenges; insulation laid on top of existing solid floors may impact on existing doors and finishes whilst lifting of a solid floor to insert insulation below will require consideration of the potential effect on both structural stability and damp proofing. It is advised to seek advice from a Chartered Structural Engineer or a registered Architect about this if unsure. Further information about floor insulation is available from many sources including [www.energysavingtrust.org.uk/scotland/Insulation/Floor-insulation](http://www.energysavingtrust.org.uk/scotland/Insulation/Floor-insulation). Building regulations generally apply to this work and may also require a building warrant so it is best to check with your local authority building standards department.

### 4 Solar photovoltaic (PV) panels

A solar PV system is one which converts light directly into electricity via panels placed on the roof with no waste and no emissions. This electricity is used throughout the home in the same way as the electricity purchased from an energy supplier. Planning permission might be required, building regulations generally apply to this work and a building warrant may be required, so it is best to check with your local authority. The assessment does not include the effect of any Feed-in Tariff which could appreciably increase the savings that are shown on this EPC for solar photovoltaic panels, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent).
