1. Information and scope of inspection

This section tells you about the type, accommodation, neighbourhood, age and construction of the property. It also tells you about the extent of the inspection and highlights anything that the surveyor could not inspect.

All references to visual inspection refer to an inspection from within the property without moving any obstructions and externally from ground level within the site and adjoining public areas. Any references to left or right in a description of the exterior of the property refer to the view of someone standing facing that part of the property from the outside.

The inspection is carried out without causing damage to the building or its contents and without endangering the occupiers or the surveyor. Heavy furniture, stored items and insulation are not moved. Unless identified in the report the surveyor will assume that no harmful or hazardous materials or techniques have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

Services such as TV/cable connection, internet connection, swimming pools and other leisure facilities etc. will not be inspected or reported on.

Description	The property comprises a substantial two storey detached dwellinghouse together with detached one bedroomed cottage and quadruple car garage set in approximately 4.7 acres of surrounding garden ground.

Neighbourhood and location	The subjects are situated in rural surroundings, lying within the Broallan district approximately 2 miles west of Beauly. Immediate surrounding properties comprise some scattered residential dwellings, together with open countryside and farmland. There are views to the east towards the Beauly and Moray Firth and Kessock Bridge. There are some local amenities available within nearby Beauly and Muir of Ord, whilst the city of Inverness is within commuting distance being approximately 14 miles east.

Roofing including roof space

The roof is of pitched design and clad with slates. There are flat roof dormer window projections which appear to be overlaid with fibreglass sheeting.

There was access gained to the main accessible roof void area via a ceiling hatch and fixed ladder within the first floor Landing. The loft area has been partly floored whilst fibreglass insulation has been laid between the ceiling joists.

The roof areas over the single storey projections are of pitched and hip ended design and clad with slates.

Sloping roofs were visually inspected with the aid of binoculars where appropriate.

Flat roofs were visually inspected from vantage points within the property and where safe and reasonable to do so from a 3m ladder externally.

Roof spaces were visually inspected and were entered where there was safe and reasonable access, normally defined as being from a 3m ladder within the property. If this is not possible, then physical access to the roof space may be taken by other means if the Surveyor deems it safe and reasonable to do so.

Rainwater fittings

The gutters and downpipes are of plastic manufacture.

Visually inspected with the aid of binoculars where appropriate.

Main walls

The vast majority of the main outer walls are consistent with being of modern cavity construction comprising a structural timber frame inner leaf and roughcasted concrete block outer leaf. Part of the ground floor is of roughcasted stone construction.

Visually inspected with the aid of binoculars where appropriate. Foundations and concealed parts were not exposed or inspected.

Garages and permanent outbuildings

There is a detached cottage pertaining to the subjects which provides additional residential accommodation. The accommodation within this annex comprises as follows:

Entrance Porch, Kitchen/Dining Area, Bathroom, Bedroom with Vestibule off, Living Room.

The total Gross internal Floor area was calculated to extend to circa 64m2 or thereby.

The outer walls are of part rendered stone construction and also part timber frame, cavity concrete block construction. The roof is of pitched design and overlaid with light weight tiles.

There is a substantial quadruple car garage which has four individual electrical metal vehicle access doors to the front. There is also a pedestrian access door and stairs leading to the upper level. The first floor of the garage has been floored and plasterboard lined and is currently utilised as an office/study area, although could be converted to additional residential accommodation, should the necessary consents be obtained.

Additional outbuildings comprise various shed/stores and greenhouse.

Visually inspected.

Outside areas and boundaries

From information provided and from that obtained from an online mapping system we understand that the total site area extends to approximately 4.7 acres or thereby. This includes the immediate surrounding garden grounds together with an additional area of woodland to the rear. We would recommend that confirmation be obtained as to the full extent of the grounds pertaining to the property.

There has been paved terraced areas having been formed to the front and side.

The boundaries, where present, are formed in block and stone walling, timber fencing and post and wire fencing.

Initial access is via a shared private driveway which we understand is outwith the ownership, subsequently leading to a private driveway and off-street car parking areas.

There are some large mature trees to the rear of the dwellinghouse.

Visually inspected.

Ceilings

The ceilings are plasterboard lined.

Visually inspected from floor level.

Internal walls

Internal walls are plasterboard lined.

Visually inspected from floor level.

Using a moisture meter, walls were randomly tested for dampness where considered appropriate.

Floors including sub floors The flooring is predominantly of suspended timber construction, assumed to comprise chipboard sheeting laid on suspended timber joists. We would, however, emphasise that our inspection of floor surface areas was restricted due to the presence of fitted floor coverings and furnishings. There was no access gained to any sub-floor areas. Surfaces of exposed floors were visually inspected. No carpets or floor coverings were lifted. Internal joinery and kitchen Internal skirtings and architraves are of hardwood type, whilst internal fittings doors are of modern timber and timber/glazed construction. There is a timber staircase connecting the ground and first floors. The Kitchen comprise a modern range of wall mounted cabinets and worktop surfaces. There are modern worktop units in the utility room. Built-in cupboards were looked into but no stored items were moved. Kitchen units were visually inspected excluding appliances. Chimney breasts and fireplaces There are modern stoves within both the Living Room/Dining Room area and Sitting Room. Visually inspected. No testing of the flues or fittings was carried out.

Electricity

Mains supply. The electrical installation comprises 13 amp power points whilst the cable where visible is of PVC clad type. The electrical meter and consumer unit is contained within a Kitchen cupboard.

Accessible parts of the wiring were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards.

Gas

Not applicable.

Water, plumbing, bathroom fittings

Mains supply. The visible plumbing installation is in copper and plastic pipework where seen.

The sanitary fittings within the Bathroom and En-Suites are all of modern replacement type.

Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards.

It should be appreciated that concealed areas beneath and around baths and shower trays could not be inspected. Water spillage in these areas can result in dampness/decay and no comment can be made on inaccessible areas. Waterproof seals in sanitary areas should be checked and maintained on a regular basis.

Heating and hot water

Fixed central heating is provided by an oil fired `Vortex Utility 26-36` boiler which is located in the Utility Room and this serves water filled radiators throughout. This also provides for domestic hot water which is supplemented by an electric immersion heater and contained within a foam insulated hot water cylinder.

Accessible parts of the system were visually inspected apart from communal systems, which were not inspected. No tests whatsoever were carried out to the system or appliances.

Drainage We understand that drainage is via a private septic tank which is located outwith the boundaries within a field to the front. Drainage covers etc were not lifted. Neither drains nor drainage systems were tested.

Fire, smoke and burglar alarms We understand there is a compliant smoke and heat alarm system within the property. Visually inspected. No tests whatsoever were carried out to the system or appliances. New smoke alarm standards were introduced in Scotland in February 2022 and it is likely that some properties may require additional works to meet these standards. In instances where alarms are in place, no tests whatsoever have been carried out and we cannot confirm if the system complies with the most recent regulations. Any potential purchaser should satisfy themselves as to whether the current system meets with regulations or otherwise.

Additional limits to inspection

At the date of inspection, the property was occupied and furnished whilst the floors were covered.

There was no access gained to any sub-floor areas.

Not all windows and doors were tested during the course of our inspection.


It is outwith the scope of this inspection to determine whether or not asbestos based products are present within the property. Asbestos was widely used in the building industry until around 1999, when it became a banned substance. If you have any concerns you should engage the services of a qualified asbestos surveyor.

Insulation has been laid over the roof joists and accordingly a head and shoulders inspection of the roof space was possible only.

No inspection for Japanese Knotweed was carried out and unless otherwise stated for the purpose of this report, it is assumed that there is no Japanese Knotweed within the boundaries of the property or neighbouring properties.

It should be appreciated that the Home Report inspection is a non-disruptive visual inspection of the property as at the date of inspection and that we are unable to inspect parts of the property which are concealed or covered by floor coverings or contents in place at that time. Once vacant, defects may be apparent that could not be detected during our survey. Changing weather conditions can also affect aspects of the property which would not be apparent at the time of inspection.

4. Valuation and conveyance issues

This section highlights information that should be checked with a solicitor or licensed conveyancer. It also gives an opinion of market value and an estimated cost for insurance purposes.

Matters for a solicitor or licensed conveyancer

We are unaware of any adverse planning proposals affecting the subjects although this should be confirmed by obtaining a Property Enquiry Certificate.

Absolute Ownership assumed. We are unaware of any easements, servitudes or rights of way which may adversely affect the property. This point should be confirmed by reference to the Title Deeds.

The valuation is made on the assumption that any alterations that may have been carried out to the property satisfy all relevant legislation and have full certification where appropriate. While not necessarily an exhaustive list, alterations noted at the time of our inspection include the various extensions/alterations, together with the addition of the car garage.

It is recommended that where repairs, defects or maintenance items have been identified, particularly categorised as a 2 or 3, interested parties make appropriate enquiries in order to satisfy themselves of potential costs and the extent of the works required prior to submitting a legal offer to purchase.

There are large trees within influencing distance of the property. It is assumed that insurance can be obtained on normal terms.

We would recommend the full extent of grounds pertaining to the property be ascertained by reference to the title.

Drainage, we understand is to a exclusive septic tank which we understand lies outwith the feu. This was not checked or tested. It should be ensured that appropriate registration documents are available.

Access to the subjects is initially via a private track which we understand is outwith the ownership. Our valuation assumes that a right of access exists over this and that any maintenance and upkeep is on a shared and equal basis.

Estimated reinstatement cost for insurance purposes

£1,450,000

It is assumed that insurance cover is obtainable on normal terms. The guidance figure is the estimate of costs for reinstating the subjects as at the date of inspection based on information provided by the Building Cost Information Service (BCIS). It is recommended that this figure is kept under regular review to ensure that you have adequate insurance cover. We are of the opinion that the subjects should be insured for buildings reinstatement purposes for a sum of not less than £1,000,000 (ONE MILLION FOUR HUNDRED AND FIFTY POUNDS STERLING).

Valuation and market comments

£790,000

We are of the opinion that the market value of the subjects all as previously described and on a vacant possession basis would be fairly stated in the region of £790,000 (SEVEN HUNDRED AND NINETY THOUSAND POUNDS STERLING).

Our valuation reflects current market conditions relating to this area. We would assume that current trends will prevail at the ultimate date of disposal with no adverse or onerous matters being introduced into the market during the intervening period which would have a detrimental effect on price.

TERMS AND CONDITIONS OF SINGLE SURVEY

GENERAL

1.1 The Surveyors

The Seller has engaged the Surveyors to provide the Report and a Generic Mortgage Valuation Report for Lending Purposes. The Seller has also engaged the Surveyors to provide an Energy Report in the format prescribed by the accredited energy company.

The Surveyors are authorised to provide a transcript or retype of the Generic Mortgage Valuation Report on to Lender specific pro-forma. Transcript reports are commonly requested by brokers and lenders. The transcript report will be in the format required by the Lender but will contain the same information, inspection date and valuation figure as the Generic Mortgage Valuation Report and the Report. The Surveyors will decline any transcript request which requires the provision of information additional to the information in the Report and the Generic Mortgage Valuation Report until the Seller has conditionally accepted an offer to purchase made in writing.

Once the Seller has conditionally accepted an offer to purchase made in writing, the Lender or conveyancer may request that the Surveyors provide general comment on standard appropriate supplementary documentation. In the event of a significant amount of documentation being provided to the Surveyors, an additional fee may be incurred by the Purchaser. Any additional fee will be agreed in writing.

If information is provided to the Surveyors during the conveyancing process which materially affects the valuation stated in the Report and Generic Mortgage Valuation Report, the Surveyors reserve the right to reconsider the valuation. Where the Surveyors are required to amend the valuation in consequence of such information, they will issue an amended Report and Generic Mortgage Valuation Report to the Seller. It is the responsibility of the Seller to ensure that the amended Report and Generic Mortgage Valuation Report are transmitted to every prospective Purchaser.

The individual Surveyor will be a member of the Royal Institution of Chartered Surveyors who is competent to survey, value and report upon residential property. *

If the Surveyors have had a previous business relationship within the past two years with the Seller or Seller's agent or relative to the Property, they will be obliged to indicate this in the adjacent box. No

The Surveyors have a written complaints handling procedure. This is available from the offices of the Surveyors at the address stated.

1.2 The Report

The Surveyors will not provide an amended Report on the Property, except to correct factual inaccuracies.

The Report will identify the nature and source of information relied upon in its preparation.

The Surveyor shall provide a Market Value of the Property, unless the condition of the Property is such that it would be inappropriate to do so. A final decision on whether a loan will be granted rests with the Lender who may impose retentions in line with their lending criteria. The date of condition and value of the property will be the date of inspection.

Prior to the 1st of December 2008, Purchasers have normally obtained their own report from their chosen Surveyor. By contrast, a Report is instructed by the Seller and made available to all potential Purchasers in expectation that the successful Purchaser will have relied upon it. The Royal Institution of Chartered Surveyors rules require disclosure of any potential conflict of interest when acting for the Seller and the Purchaser in the same transaction. The Report may give rise to a conflict of interest and if this is of concern to any party they are advised to seek their own independent advice.

The Report and any expressions or assessments in it are not intended as advice to the Seller or Purchaser or any other person in relation to an asking price or any other sales or marketing decisions.

The Report is based solely on the Property and is not to be relied upon in any manner whatsoever when considering the valuation or condition of any other property.






Energy Efficiency Rating

Summary of the energy performance related features of this home

The energy efficiency rating of your home

Your Energy Efficiency Rating is calculated using the standard UK methodology, RdSAP. This calculates energy used for heating, hot water, lighting and ventilation and then applies fuel costs to that energy use to give an overall rating for your home. The rating is given on a scale of 1 to 100. Other than the cost of fuel for electrical appliances and for cooking, a building with a rating of 100 would cost almost nothing to run.

As we all use our homes in different ways, the energy rating is calculated using standard occupancy assumptions which may be different from the way you use it. The rating also uses national weather information to allow comparison between buildings in different parts of Scotland. However, to make information more relevant to your home, local weather data is used to calculate your energy use, CO₂ emissions, running costs and the savings possible from making improvements.

The impact of your home on the environment

One of the biggest contributors to global warming is carbon dioxide. The energy we use for heating, lighting and power in our homes produces over a quarter of the UK's carbon dioxide emissions. Different fuels produce different amounts of carbon dioxide for every kilowatt hour (kWh) of energy used. The Environmental Impact Rating of your home is calculated by applying these 'carbon factors' for the fuels you use to your overall energy use.

The calculated emissions for your home are 40 kg $CO_2/m^2/yr$.

The average Scottish household produces about 6 tonnes of carbon dioxide every year. Based on this assessment, heating and lighting this home currently produces approximately 14 tonnes of carbon dioxide every year. Adopting recommendations in this report can reduce emissions and protect the environment. If you were to install all of these recommendations this could reduce emissions by 5.0 tonnes per year. You could reduce emissions even more by switching to renewable energy sources.

About the recommended measures to improve your home's performance rating

This section offers additional information and advice on the recommended improvement measures for your home

1 Floor insulation (suspended floor)

Insulation of a floor will significantly reduce heat loss; this will improve levels of comfort, reduce energy use and lower fuel bills. Suspended floors can often be insulated from below but must have adequate ventilation to prevent dampness; seek advice about this if unsure. Further information about floor insulation is available from many sources including www.energysavingtrust.org.uk/scotland/Insulation/Floor-insulation. Building regulations generally apply to this work so it is best to check with your local authority building standards department.

2 Heating controls (room thermostat)

The heating system should have a room thermostat to enable the boiler to switch off when no heat is required. A competent heating engineer should be asked to do this work. Insist that the thermostat switches off the boiler as well as the pump and that the thermostatic radiator valve is removed from any radiator in the same room as the thermostat. Building regulations generally apply to this work and a building warrant may be required, so it is best to check with your local authority building standards department and seek advice from a qualified heating engineer.

3 Solar water heating

A solar water heating panel, usually fixed to the roof, uses the sun to pre-heat the hot water supply. This can significantly reduce the demand on the heating system to provide hot water and hence save fuel and money. Planning permission might be required, building regulations generally apply to this work and a building warrant may be required, so it is best to check these with your local authority. You could be eligible for Renewable Heat Incentive payments which could appreciably increase the savings beyond those shown on your EPC, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent). Details of local MCS installers are available at www.microgenerationcertification.org.

4 Solar photovoltaic (PV) panels

A solar PV system is one which converts light directly into electricity via panels placed on the roof with no waste and no emissions. This electricity is used throughout the home in the same way as the electricity purchased from an energy supplier. Planning permission might be required, building regulations generally apply to this work and a building warrant may be required, so it is best to check with your local authority. The assessment does not include the effect of any Feed-in Tariff which could appreciably increase the savings that are shown on this EPC for solar photovoltaic panels, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent). Details of local MCS installers are available at www.microgenerationcertification.org.

5 Wind turbine

A wind turbine provides electricity from wind energy. This electricity is used throughout the home in the same way as the electricity purchased from an energy supplier. Wind turbines are not suitable for all properties. The system's effectiveness depends on local wind speeds and the presence of nearby obstructions, and a site survey should be undertaken by an accredited installer. Planning permission might be required and building regulations generally apply to this work and a building warrant may be required, so it is best to check these with your local authority. The assessment does not include the effect of any Feed-in Tariff which could appreciably increase the savings that are shown on this EPC for a wind turbine, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent). Low and zero carbon energy sources

Low and zero carbon (LZC) energy sources are sources of energy that release either very little or no carbon dioxide into the atmosphere when they are used. Installing these sources may help reduce energy bills as well as cutting carbon.
